


ORDINANCE # 2025- 14AN ORDINANCE DECLARING CERTAIN PROPERTY TO BE
SURPLUS PROPERTY AND AUTHORIZING ITS CONVEYANCE

THE CITY OF CLAREMORE HEREBY ORDAINS:

Section 1: The City of Claremore owns the following described property, to wit:*The real property described on Exhibits A, B, C, and D attached hereto and made a part hereof.*Section 2: The City has no further need for the property described in Section 1 and on Exhibits A, B, C, and D, and said property is therefore declared to be surplus and hereby authorized to be sold or conveyed. This property does not constitute a "public utility," as defined by Okla. Stat. tit. 11, § 35-201.Section 3: This ordinance shall be referred to a vote of the electors of the City if a proper referendum petition is properly filed within thirty (30) days after its passage; otherwise, it shall go into effect thirty (30) days after the passage.Section 4: The Mayor is hereby authorized to execute any and all conveyances on behalf of the City which are necessary to effectuate this ordinance.PASSED AND APPROVED in regular session this 4th day of August, 2025.



Exhibit A

Parcel I

Legal Description:

A tract of land that is part of the Northwest Quarter (NW/4) of Section Twenty (20), Township Twenty-one (21) North, Range Sixteen (16) East of the Indian Base and Meridian (I.B.&M), Rogers County, State of Oklahoma, according to the U.S. Government Survey thereof, said tract of land being described as follows:

Commencing at the Northwest corner of Section 20; Thence North 88°48'49" East along the Northerly line of Section 20, and along the Northerly line of Claremore Plaza, an addition to the City of Claremore, Rogers County, State of Oklahoma, according to the recorded plat thereof, for 1527.05 feet to the Northeast corner of said Claremore Plaza; Thence South 01°19'22" East along the Easterly line of said Claremore Plaza for 470.41 feet to the Point of Beginning; Thence North 88°48'49" East parallel with the Northerly line of Section 20 for 450.58 feet to a point on the Westerly line of The Villas at Country Club Crossing, an addition to the City of Claremore, Rogers County, State of Oklahoma, according to the recorded plat thereof; Thence South 01°19'45" East along said Westerly line for 190.13 feet to the Southwest corner of The Villas at Country Club Crossing, the same being the Northwest corner of Lot Sixteen (16), Block One (1), Harvest Hill Amended, an addition to the City of Claremore, Rogers County, State of Oklahoma, according to the recorded plat thereof; Thence South 01°20'06" East along the Westerly line of Harvest Hills Amended, for 660.41 feet to the Southwest corner of Lot Twenty-Four (24), Block One (1), Harvest Hills Amended; Thence North 88°46'58" East along a Westerly line of Block 1 for 659.23 feet to the Northwest corner of Lot 35, Block 1, Harvest Hill Amended and the Easterly line of said NW/4 of Section 20; Thence South 01°20'04" East along said Easterly line and a Westerly line of Block 1 for 660.30 feet; Thence continuing along said Easterly line S 01°22'02" E for 109.11 feet to a point of curve; Thence Northwesterly along a curve to the right with a radius of 75.00 feet, a chord bearing of North 62°05'50" West, a chord distance of 36.35 feet, and an arc length of 36.72 feet; Thence North 48°04'18" West for 247.91 feet to a point of curve; Thence Northwesterly along a curve to the left with a radius of 135.00 feet, a chord bearing of North 69°38'03" West, a chord distance of 99.23 feet for an arc length of 101.61 feet; Thence South 88°48'13" West 60.00 feet Northerly of and parallel with the Northerly line of Tract 3 Revised, Deer Run Amendment Plat, an addition to the City of Claremore, Rogers County, State of Oklahoma, according to the recorded plat thereof, for 1211.73 feet; Thence North 84°04'20" West for 155.86 feet; Thence North 68°51'14" West for 136.07 feet; Thence North 06°45'51" West for 134.92 feet; Thence North 11°09'02" West for 51.64 feet to a point on the South line of Lot One (1), Block One (1), Claremore Plaza Phase II, an addition to the City of Claremore, Rogers County, State of Oklahoma, according to the recorded plat thereof; Thence North 88°40'13" east along said South line for 473.94 feet to the Southeast corner of said Lot 1; Thence North 01°19'16" West along the Easterly line of said Lot 1 for 116.77 feet to a point of curve; Thence along said Easterly line and Northeasterly along a curve to the right with a radius of 530.00 feet, a chord bearing of North 07°01'45" East, a chord distance of 153.94 feet, for an arc length of 154.49 feet; Thence North 27°21'15" West along said Easterly line for 36.72 feet to

a point of curve; Thence along said Easterly line and Northeasterly along a curve to the right with a radius of 537.65 feet, a chord bearing of North $61^{\circ}00'59''$ West, a chord distance of 138.96 feet, for an arc length of 139.35 feet; Thence North $42^{\circ}20'05''$ East for 210.50 feet; Thence North $47^{\circ}39'55''$ West for 300.00 feet; Thence Northeasterly along a curve to the left with a radius of 440.00 feet, a chord bearing of North $21^{\circ}54'57''$ East, a chord distance of 209.19 feet. For an arc length of 211.21 feet to the Southwest corner of Lot 2, Claremore Plaza; Thence South $81^{\circ}50'11''$ East along the Southerly line of said Lot 2 for 20.00 feet; Thence North $88^{\circ}48'49''$ East along said Southerly line for 317.24 feet to the Southeast corner of said Lot 2; Thence North $01^{\circ}19'22''$ West along the Easterly line of said Lot 2 for 218.59 feet to the Point of Beginning.
